Position	Directing Attorney – Immigration Unit (Full-time)
Organization Description	The Public Law Center (PLC), Orange County's non-profit <i>pro bono</i> law firm, is committed to providing access to justice for low-income residents. Through volunteers and staff, PLC provides free civil legal services, including counseling, individual representation, community education, and strategic litigation and advocacy to challenge societal injustices. Now in its 36 th year of service, PLC works with more than 1,400 volunteer lawyers, paralegals and law students from throughout the county who volunteer their time and expertise. The Immigration Unit provides assistance in the following areas: "U" visas, "T" visas, Asylum, SIJS, DACA, naturalization, and deportation defense. The Directing Attorney would be expected to provide assistance in these areas through direct representation and providing technical assistance to our pro bono volunteers.
