NOTICE IS FURTHER GIVEN that [PARTY DESIGNATION] will conduct this
deposition utilizing the secure web-based deposition option afforded by Esquire Court Reporters
through ZOOM. Also take notice that the court reporter will be remote via ZOOM and will not be
in the presence of the deponent, and the court reporter will swear in the witness remotely as
permitted by Emergency Rule 11.

Attached to this Notice of Deposition and incorporated hereinto this Notice as Exhibit "A"

9 is Esquire Court Reporters' *Remote Deposition Minimum Technical Requirements and Best*

10 *Practices*. Counsel for the witness is requested to contact the noticing attorney at least five (5)

11 business days prior to the deposition to advise that the witness and her counsel can comply with the

12 *Remote Deposition Minimum Technical Requirements and Best Practices* and so that the necessary

credentials, call-in numbers, testing and information, if necessary, can be provided to counsel or the
witness prior to the proceedings. In addition, [PARTY DESIGNATION] also reserves the right to
utilize instant visual display technology such that the court reporter's writing of the proceeding will
be displayed simultaneous to their writing of same on one's laptop, iPad, tablet or other type of
display device connected to the court reporter.

The deposition will be taken before a court reporter authorized to administer oaths under the
laws of the State of California pursuant to California <u>Code of Civil Procedure</u> Section 2025.320. If
an interpreter is needed at this deposition, this office must be notified no later than five (5) days
prior to the deposition of the language/dialect necessary.

Additionally, [PARTY DESIGNATION] reserves the right to record this deposition via
 electronic video and/or audio tape recording in addition to recording the testimony by stenographic
 methods pursuant to California <u>Code of Civil Procedure</u> Section 2025.330. Moreover, [PARTY]
 DESIGNATION] reserves the right to utilize the electronic video and/or audio tape recording for
 any and all purposes at the time of trial pursuant to California <u>Code of Civil Procedure</u>, Sections
 2025.330, 2025.340, and 2025.620.
