Orange County Bar Association Charitable Fund Announces Grants To Law-related Charities throughout Orange County

NEWPORT BEACH, Calif., Feb. 17, 2017 – The Orange County Bar Association Charitable Fund announced it will award \$179,600 in grants to 12 law-related organizations and programs in Orange County. The programs provide critically needed services to a broad range of clients including victims of domestic violence, legal services for low-income residents of Orange County and foster youth, diversity pipe-line efforts and assistance for homeless residents.

Selected by the OCBA Charitable Fund Board, the grants were presented at the OCBA Charitable Fund Grant Giving Reception held on Thursday, Feb. 16, 2017, at OCBA Headquarters in Newport Beach, Calif. Ms. Ashleigh Aitken, OCBA Charitable Fund Immediate Past President, presented the grants on behalf of the Charitable Fund.

"People in Orange County face an array of legal concerns every day, and these organizations are often at the forefront of providing legal support and services," said Aitken. "We're proud to partner with them and together we can facilitate access to justice for all."
