# Orange County Bar Association Charitable Fund Honors Knobbe Martens, CHOC, And Law-Related Charitable Programs in Orange County at 2018 Annual Benefit

NEWPORT BEACH, Calif., Aug. 21, 2018 – The Orange County Bar Association Charitable Fund will honor law firm Knobbe Martens, Children's Hospital of Orange County (CHOC), and four law-related charities in Orange County during its annual "Raise Your Glass" benefit. Knobbe Martens was selected as the 2018 Law Firm Honoree of the OCBA Charitable Fund annual benefit, CHOC as the Corporate Honoree, and four local organizations as the Community Partner Honorees for their dedication to serving victims of domestic violence – Chapman University Fowler School of Law's Bette and Wylie Aitken Family Protection Clinic, Human Options, Laura's House, and Women's Transitional Living Center (WLTC).

Each year, the OCBA Charitable Fund hosts its "Raise Your Glass" gala – a wine tasting and charity awards benefit. The benefit will be held at Newport Beach Country Club this Thursday, August 23, 2018. It includes great wines, culinary delights, live entertainment, and both a silent and live auction. The evening's festivities are preceded by a VIP champagne reception.

Proceeds from the event will be used to fund donations to various law-related charities in the Orange County community. The OCBA Charitable Fund grants provide critically needed services to a broad range of clients including victims of domestic violence, legal services for low-income residents of Orange County and foster youth, diversity pipe-line efforts, and assistance for veterans and homeless residents.

"This year's Charitable Fund honorees are recognized for the important legal services they provide to some of the most vulnerable and underserved members of our community," said OCBA Charitable Fund President Michael Baroni. "The work of these organizations, lawyers, and advocates has greatly expanded the public's access to justice and impacted countless lives and families in Orange County."
