YOUNG LAWYERS DIVISION CHAIR RESPONSIBILITIES

It is expected that the YLD Chair will:

- Participate on the OCBA Board of Directors (BOD) and in the Board Orientation Program as a YLD representative, if appointed.
- If appointed, attend at least nine BOD meetings per year – generally one evening per month.
- Be a liaison and attend key meetings for assigned standing committees and other boards or task forces as assigned by the OCBA President.
- Represent the OCBA Young Lawyers Division at public speaking events and appearances as requested by the OCBA.
- Attend YLD events and activities.
- Attend various OCBA sponsored events such as Judges' Night, New Member Reception, and other special events.
- Assist with the development and recruitment of YLD leaders and members.
- Promote YLD to law schools, other groups and organizations.
- Appoint YLD Committee Chairs (i.e. community outreach, education, social, sports).
- Hold YLD Committee Chair meetings as needed.
- Chair YLD business meetings.
- Oversee subcommittee planning of up to 16 annual YLD events and activities that appeal to all YLD members.
