All Young Lawyers Division (YLD) members in practice three years or less are encouraged to submit a nomination to serve as the position of 2017 YLD Chair-Elect. The 2017 YLD Chair-Elect will be chosen by the current YLD membership during an election held from December 1, 2016 to December 15, 2016.

The YLD Chair-Elect serves for one calendar year and thereafter elevates to serve as the YLD Chair for the following calendar year. The YLD Chair-Elect assists the YLD Chair in carrying out the duties of the YLD Chair, which include acting as the supervisory and ceremonial leader of the YLD. The YLD provides resources specifically tailored to OCBA members who have been in practice for five years or less. These resources provide a variety of professional, educational, and social opportunities to YLD members such as Continuing Legal Education (CLE) seminars, community service events, and athletic activities. Participating in YLD leadership is an ideal way to meet new attorneys and jump-start one's involvement in the Orange County Bar Association.

### YLD CHAIR RESPONSIBILITIES

- Oversee the planning and execution of up to 16 annual YLD events
- Appoint YLD Committee Chairs
- Call and preside over YLD Committee Chair meetings, as needed
- Call and preside over YLD business meetings
- Assist with the development and recruitment of YLD leaders and members
- Attend YLD events
- Attend OCBA sponsored events
- Promote YLD to law schools and community organizations
- Represent the YLD as a voting member of the OCBA Board of Directors (BOD) for at least nine monthly BOD meetings per year
- Represent the YLD on the Board Orientation Program, if appointed
- Represent the YLD at public speaking events, as requested by the OCBA or the OCBA President
- Act as a BOD liaison at meetings for OCBA standing committees, boards, or task forces, as requested by the OCBA President
