
in We did the Meeting someone ald ike Thi Tm Wil ts hold 2 "I did not start this virus."

Speaker Biographies

PANELIST - DEAN JUSTIN CRUZ

Dean Cruz serves as Assistant Dean of Admission and Diversity Initiatives at Chapman University's Fowler School of Law. After receiving his JD from Washington University School of Law in Missouri, he worked as an intellectual property law attorney for a Fortune 500 company. Recognizing that his passion was in educating future generations, he began serving as an Adjunct Professor and Assistant Director of Admissions at Thomas Jefferson School of Law in San Diego and then as the Associate Dean of Student Affairs at Barry University School of Law in Florida before joining us here in Orange County at the Chapman Fowler School of Law.

In addition to embodying diversity in practice, he similarly reflects diversity in heritage, which has empowered his dedication to a myriad of diversity and inclusion initiatives, including Law School Admission Council (LSAC) Diversity Committee, the Annual Meeting of Law School Diversity Professionals (AMLSDP), Thurgood Marshall Bar Association, and the American Bar Association (ABA) Young Lawyer's Division Minorities in the Profession Committee (MIPC).



PANELIST - MAY LEE



May Lee has been a broadcast and digital journalist for three decades as both a US and international anchor, host, correspondent and producer. A second generation Korean American, May faced gender discrimination and anti-Asian bias early in her career, and spent the 1980s moving between local broadcasters. However, she reached a turning point in 1995, when she joined CNN; she first worked as a correspondent in Tokyo and Hong Kong, and later became the network's first female anchor of Korean descent.

Her subsequent successes only further embody her incredible dedication to diversity, inclusion, and her tremendous aptitude as an advocate for the same. She's served as a talk show host on Oxygen Media's flagship show, "Pure Oxygen", she served as anchor for the "Asian Wall Street Journal", CNBC's Asian financial news program, and has even coanchored "CNBC's Tonight" with Teymoor Nabili. Most recently, she launched her own show, appropriately entitled "The May Lee Show", where she confronts a multitude of issues, including the topic of implicit bias in our global community – the very subject that shall be discussed today.

Mei Tsang is an intellectual property attorney with the Irvine based firm Umberg Zipser LLP. She herself comes from very diverse background; being an immigrant to this county at age 13, speaking both Mandarin and Cantonese, Mei openly and enthusiastically advocates for diversity, by bringing her Chinese-American perspective to her work and advocacy as she serves on the Board of Directors for both the Orange County Bar Association and the OCBA's Charitable Fund. She similarly serves as cochair of the OCBA's Diversity Committee and served as a driving force for today's very webinar focusing on diversity and inclusion.
