SECOND AMENDED ADMINISTRATIVE ORDER NO. 20/14

EMERGENCY 90-DAY EXTENSION OF CRIMINAL PROTECTIVE ORDERS AUTHORIZED BY THE JUDICIAL COUNCIL OF CALIFORNIA

On April 6, 2020, the Judicial Council of the State of California adopted eleven (11) temporary emergency rules of court in response to the COVID-19 pandemic. The emergency rules of court were adopted effective April 6, 2020. Emergency Rule of Court, Rule 8(b)(3) provides, "Any criminal protective order, subject to this rule, set to expire during the state of emergency, must be automatically extended for a period of 90 days, or until the matter can be heard, whichever occurs first."


A Third Implementation Order re: Emergency Order (Gov. Code, § 68115) declared April 24, 2020, through May 22, 2020, inclusively, as holidays for purposes of computing the time for the filing of papers with the Court.

Pursuant to Emergency Rule of Court, Rule 8(b)(3), each Criminal Protective Order identified in Exhibit A and Exhibit B to this order shall remain in effect for 90 days from the date it was set to expire. The final column in Exhibit A and Exhibit B identifies the new expiration date. Exhibit B identifies Criminal Protective Orders set to expire April 25, 2020, through May 22, 2020
