Coordinates efforts among the legal community to enhance deportation defense services.

Project: Orange County Expanded Domestic Violence Assistance Project Grant awarded: \$25,000

Provides free civil legal services, including counseling, individual representation, community education and strategic litigation and advocacy to challenge societal injustices.
