**Common Evidentiary Issues in Employment Cases**

Disputes over evidentiary issues lie at the core of most employment cases, given that the presence of animus is often proven through testimonial or circumstantial evidence. These disputes are particularly acute in harassment cases, which often involve inflammatory testimony and exhibits. This program will focus on evidentiary issues plaintiffs and defendants frequently encounter in investigating or litigating sexual harassment, discrimination, and wrongful termination claims, including the treatment of privilege issues, testimonial and circumstantial evidence, and various forms of documentary evidence.
