Pregnancy and Beyond: Understanding Workplace Accommodation, Leave, and Lactation Rights

Multiple laws and regulations protect pregnant women and new mothers in the workplace. Recent regulations and cases have further clarified and expanded upon employers' obligations to provide accommodations and protections. This panel will cover the most frequent issues that arise in the workplace from early pregnancy through the postpartum period. The panel will address requests for accommodations and transfers both during pregnancy and in the post-postpartum period; pregnancy, childbirth, and baby-bonding leave coverage; understanding job-protected leave vs. paid leave via the EDD; and lactation-related accommodations.
