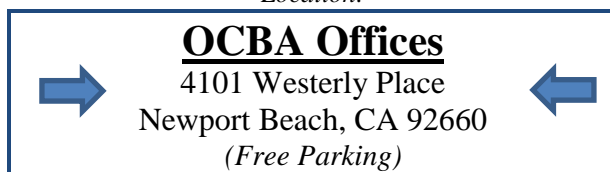
Fair International Trade and State Law/Enforcement

This program will review State government approaches to international trade. These include pursuing litigation against foreign companies that engage in software piracy to gain a commercial advantage against domestic competitors, using intellectual property protection for re-shoring, and state unfair competition laws. The need for increased cooperation between countries and courts in addressing judgments will also be covered.
