# Pitzer College v. Indian Harbor Insurance Company: Where Do We Go Now?

In August, the California Supreme Court unanimously held that the notice-prejudice rule is a "fundamental public policy" for choice-of-law purposes, and that it applies to consent provisions in first-party policies.
