E. Randol Schoenberg is of-counsel and co-founding partner of Burris, Schoenberg & Walden, LLP, where he specialized in cases involving looted art and the recovery of property stolen by the Nazi authorities during the Holocaust.

Topic:

Attorney Randy Schoenberg will discuss his experience representing Ms. Altmann before the United States Supreme Court in *Republic of Austria v. Altmann*, 541 U.S. 677 (2004) — a case in which the U.S. Supreme Court held that the Foreign Sovereign Immunities Act (FSIA) applies retroactively. The result of this case permitted plaintiff to proceed with a civil action against Austria in a U.S. Federal District Court for recovery of five paintings stolen by the Nazis from her relatives.
