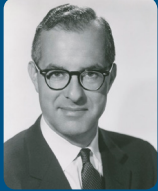

**Stanley Mosk (1912 – 2001)** was an Associate Justice of the California Supreme Court for 37 years (1964–2001), and thus holds the record for the longest-serving justice on that court. Before sitting on the Supreme Court, he served as Attorney General of California for six years and as a trial court judge. The Los Angeles County Courthouse is named after him. In addition, the Stanley Mosk Library & Courts Building is located on the Capitol Mall in Sacramento, California and is the home of the California Court of Appeal for the Third District.
