Orange County Bar Association to Install Attorney Todd G. Friedland as President

In addition to his service on the OCBA’s Executive Committee and Board of Directors, Mr. Friedland sits on the Board of Governors for the Association of Business Trial Lawyers, Orange County Chapter, and is a Past President of Constitutional Rights Foundation, Orange County (CRF-OC) where he continues to serve on the Board of Directors. Mr. Friedland has been selected as a Southern California Super Lawyer for the past five consecutive years, is listed in Best Lawyers, holds an Avvo 10.0 “Superb” rating, and is AV Rated by Martindale-Hubbell Peer Review.

Orange County Superior Court Presiding Judge Charles Margines will install Mr. Friedland along with the rest of the 2016 OCBA Officers, Directors, and Charitable Fund Directors during Judges’ Night, the Association’s largest annual event. A special highlight of the evening will be the presentation of the Franklin G. West Award to attorney Richard W. Millar, Jr., of Millar, Hodges & Bemis.
