## Insuring Property Against Contamination: Present-Day Alternatives Since the 1986 Absolute Exclusion

This seminar will focus on current trends and best practices for environmental insurance, including strategic considerations in real estate transactions involving (potentially or actually) environmentally-impaired properties. The seminar will address key distinctions between environmental claims under commercial general liability policies issued before adoption of the "absolute pollution exclusion" versus present-day pollution legal liability products.
